• **Polymic Conditional Use Request** Keller Engineering presented the site plan for new Polymic facility. Mr. Hsu discussed the nature of his business. The company is proposing an 80' x 100' building. The company experiments with plastic manufacturing. There is minimum waste. Most of the company's function is providing technical support on processing condition and formulation of plastics. There are no solvents used on site, only plastic resins are left over. The company uses a "closed system" so all chemicals are recycled in-house. With no other questions, Mr. Fugate moved to recommend approval to the Supervisors. Mr. Breon seconded the motion.

Mr. Gay noted Amy Story, our old engineer, is currently employed at State College Borough as their municipal engineer.

Mr. Fugate noted Bellefonte Lime Company (Graybec) will be closing its doors within the next 3 to 5 years in Coleville and moving its entire operation to Pleasant Gap. Graybec is also dropping its prices to undercut Con-Lime. Questions arose as to whether or not Graybec would buy-out Con-Lime to get access to its minerals up on Fillmore Road. It was questioned whether or not the railroad would still be built. Mr. Fugate understands Graybec wants to keep its DEP permit for deep mining active and to do so it would have to excavate 100 tons of material a year.
