Mrs. McGowan is concerned about applying the new proposed regulations to the existing Commercial district along the Benner Pike and its effects to the existing businesses as far as setbacks, and the effects of making these lots nonconforming to the new regulations. The Commission decided to let the Supervisors discuss this issue, and if needed, pass this concern back to the Commission if further discussion is needed. With no other comments, Mr. Fugate moved to pass the Overlay District Ordinance for I -99 on to the Supervisors for final consideration. Mr. Porter seconded the motion.
