NEW BUSINESS

<u>ARL Test Track Conditional Use Request:</u> Mr. Lynn Auman of Penn Terra, explained to the Commission the request to expand the bus maintenance facility at the ARL Test Track. A 10,000 sq. ft building addition is proposed. More paving is also proposed, along with an increase in the existing stormwater detention facility. No additional manpower is required so no new parking, water or septic increase is needed. The building will be 26 ft. tall, and FAA regulations will be reviewed to see if an impact exists. Mr. Dannaker expressed he did not believe so. The use is an expansion of the existing bus facility. With no other comments, Mr. Shultz moved to recommend approval to the Supervisors. Mr. Breon seconded the motion.

<u>General Aviation Hangar Facility Phase 6A:</u> Kelly Harris presented the plan to the Commission for final review and comment. All comments have been addressed. This will be the third hangar to be constructed at the airport as outlined in the preliminary plan. Mr. Porter asked about landscaping. Mr. Harris noted the University is preparing a "Master Plan" for landscaping for the entire airport area. At this time no landscaping is proposed. This hangar will look very much like the other hangars already constructed with some minor alterations. Hershey Life Line is expected to occupy this hangar. Oil water separators will be installed along with an paved apron to taxi planes out onto the runway. With no other concerns, Mr. Gay moved to approve the plan. Mr. Shultz seconded the motion.
