<u>Centre Regional Planning - Traffic Forecasting:</u> Trish Meek from Centre Region Planning Office was present to discuss the Centre Regional Traffic Forecasting Projections. Ms. Meek is following up from the July 24th meeting with the Planning Commission. Projections for the next 30 years are being formulated for Centre County for the following time periods: 2003-2005; 2006-2010; 2011-2015; 2016-2020; and 2021-2030. This model is to predict the location, type and timing of growth expected to occur within the County until 2030. The Commission reviewed the mapping of Benner Township and targeted growth areas. The following table outlines the forecasts for Benner Township from 2003-2030:
