### PERSONS TO ADDRESS THE BOARD

<u>Hampton Hills Subdivision</u>: David Pike from Penn Terra Engineering was present to present to the Board the preliminary plan of Hampton Hills. Mr. Pike noted that the plan will have 76 single family home lots. The development is currently planned to be serviced by public sewer and a community well. Mr. Pike noted that the inner loop of the development will have a sidewalk installed along the roadway. It was noted that they will have to complete a traffic study in order for Penn Dot to issue their HOP. Mr. Glantz noted that they expect that most of the homes will be between 1,100 sq. ft. and 1,600 sq. ft. in size and ranch type design. <u>Bob Hohn:</u> Mr. Hohn was present to present a petition from the residents of Crestview asking that the Supervisors look into having the developer of Crestview hire a hydrologist to study the water in the area before additional lots are created.

The Board noted that they have similar concerns with the water needs in the area of the Benner Elementary School. The Board noted that they have called for a special meeting for Wednesday evening of the school and the developers in the area to discuss water issues.

<u>Jack Rimer:</u> Mr. Rimer was present to update the Board on the Water Authorities activities.

\*It was noted that Continental Courts line is scheduled to be bored under 550 on October 18<sup>th</sup>.

\*Both State College Borough Water Authority and the Benner Township Water Authority have not changed their position relative to allowing Fullington Bus to refuel on site.

\*Mr. Rimer reported that they still have not heard anything back from the College Township Water Authority. Mr. Kelleher noted that he just spoke with the one member of that Authority and that we should be hearing something shortly.

\*Lastly, Mr. Rimer noted that the Board will need to appoint a new authority member to serve as liaison to the State College Borough Water Authority.

<u>Doug Weikel</u>: Mr. Weikel updated the Board on where Fullington is in obtaining their HOP.
