# Penn State University Conditional Use July 16, 2001

The Conditional Use hearing for Penn State University (for the purpose of rendering a decision on the relocation of the runway lights from 100' to 150') was called to order at 7:37 p.m. by the Chairman Richard Lahr with member Michael Kelleher present. Dave Breon was absent. Also in attendance were Doug Weikel, Katie Ombalski, Clair Stem, Brian Rodgers, Robert Finley, Larry Jodon, John Sepp and Renee McGowan.

Mr. Lahr read through the Board's decision. The Board's decision remained as drafted with the following changes:

- a) The Condition dealing with evergreen trees being planted along Rock Road was deleted.
- b) Condition #7 was changed to read: "No audible alarms shall be used between the hours of 7 PM and 7AM."

Ms. Ombalski noted that the second reason for her attendance is to ask the Board if they would consider pledging \$1,287 a year for the next three years towards the continuation of the Water Resource Project. Ms. Ombalski noted that she wasn't sure if it did or not but would get back to the Board with the answer.

<u>PSU Windrow</u>: It was noted that the Township has been contacted by contractors who are bidding on a Penn State project that includes the removal of the stump windrow that was placed along Fox Hill Road and Rock Road when the runway widening project took place. Ms. McGowan noted that she will be meeting with Brian Rodgers to view the area where the work is to take place.
