AT & T Conditional Use Request October 1, 2001

The conditional use hearing for AT & T was tabled at the request of AT & T due to the fact at the present time they cannot meet the current setbacks as required in the Township's Ordinances.

Overlay District Ordinance Hearing October 1, 2001

The Overlay District Ordinance Hearing was called to order at 7:30 p.m. by the Chairman, Richard Lahr with members Dave Breon and Michael Kelleher present. Also in attendance were Gerald Rogers, Ronnie Rogers, Dr. Gerald Clair, Susan Clair, Jon Eich, Clair Stem and Renee Swancer.

<u>Gerald Rogers</u>: Mr. Rogers questioned why the township still has the ¼ mile overlay zone on each side of the interchange when the other townships have lessened their requirements to 1/8 mile. Discussion was held. Mr. Breon explained the Rishel Hill interchange zone will end at the entrance into Penn Eagle I ndustrial Park.

<u>Dr. Gerald Clair:</u> Dr. Clair discussed the proposed 100' setback requirement. Dr. Clair expressed that the developer should be able to receive a tax credit for this 100 foot of setback area and that the area should be turned over to the Township, Centre Region or other agency. If no tax credit can be given, then he stated that he feels that this area should be purchased by the township or state at the same price the developer paid for it and turned over to the agency that purchases it.

Discussion was held on water and sewer needs for the Shiloh interchange area. Dr. Clair expressed that he feels the township should start discussions with UAJA and SBWJA about sewer service to this area.

<u>Gerald Rogers</u>: Mr. Rogers asked what in the ordinance has changed since the last time it was proposed for adoption.

Mrs. Swancer reported the following:

Section 6.2 On-premises sign. Remove the work "replaced" from "All signed proposed and installed (and replaced) within an Interchange Overlay Zone after the effective date of this Article shall conform to the standards set forth below, in addition to the regulations outlined in the *Benner Township Sign Ordinance No. 74 as amended.*

Definitions: Vehicle access is defined in the definition section.

I tems the Planning Commission Discussed but did not change:

- 1. Bike Storage Requirements
- 2. ¼ mile versus 1/8 mile

3. Tree preservation section

4. 800 ft. separation for vehicle access

5. Landscaping

6. Slopes

Vehicle access was defined as being a "permitted" access. No farm lanes.

Mr. Lahr moved to pass this ordinance back to the Planning Commission for consideration on the items that Dr. Clair discussed. Mr. Kelleher seconded the motion.
