- 1) Adding a new Campus Industrial Zone
- 2) Applying the use of transferable development rights as a sending area from the Conservation Zone.
- 3) Revising the future land use designation for approximately 33 acres located on the Northeast corner of the I-99 and Benner Pike interchange from the conservation and agriculture zones to the Highway Commercial Zone
- 4) Revising the future land use designation for approximately 49 acres located southeast of the I-99 and Benner Pike interchange from the Agriculture Zone to the Light Industrial Zone
- 5) Revising the future land use designation for approximately 469 acres located straddling the Benner Pike at I-999 interchange from the Public and Agriculture Zones to the Campus Industrial Zone.

It was noted that on page 4 of the resolution, Revision 8 half way down the page should read: The Future Land Use Map identifies about 469 acres within the *Campus Industrial* Zone and not "Regional Commercial" as this was a typo-graphical error.
