# Ordinance 125 Public Hearing April 6, 2015

Mrs. Schoch gave an overview of the amendments that Ordinance 125 addresses as follows:

\*Includes "Agricultural Tourism" as a conditional use within the Agricultural Zoning District.

\* Includes roadside/garden stands as a conditional use within the Highway Commercial and Regional Commercial Zoning Districts

\*Removes Section 107 from the Zoning Ordinance

\*Amends the ordinance that allow the FAA to preempt the Township Zoning Ordinance

\*Include Language to only regulate properties that affect Spring Creek within the Canyon Conservation Overlay

\*Change the height requirements within the Highway Commercial District.

John Marchek of Turtle Hill Lane noted that he felt that only the bare minimum of conditions were included in the ordinance revision and feels that the nature of the business and past history of their activities should have been taken into consideration.

Mrs. Schoch noted that the Planning Commission took into consideration of the comments made by both the neighbors and the Powells and came up with a compromise of both sides.

Mrs. Schoch noted that many of FAA's requirements pre-empt the Township's ordinance and it didn't make sense to have some of the regulations when it required the airport to continually go to the Zoning Hearing Board for approval of things when the FAA wouldn't allow what the township was requiring.

An amendment was made to the Canyon Overlay Ordinance so that those projects who had stormwater flow to Buffalo Run was exempt.

The height restrictions were changed from 45' to 70' to allow for hotels.

The hearing was closed the time being. 7:19 p.m. It was noted that the Board would consider adoption at their May 4, 2015 meeting.

\*Amberleigh – it was noted that the office is still receiving calls about the no parking along the streets of Amberleigh. It was noted that there were apparently some problems recently when there was an emergency call.

### ZONING OFFICER'S REPORT

Mrs. Schoch reported on the following:

The Planning Commission met on March 26<sup>th</sup>.

The land development plan of SCI Rockview for the additional restricted housing unit was presented.

The proposed zoning ordinance draft review was started. Some major concerns were:

\*Having too many uses that may not be compatible in one zoning district.

\*Only having one residential zoning district that allows for all kinds of housing.

\*Too many special exceptions – Attorney Rayman also had concerns regarding this as these are most common being litigated.

\*Conservation Subdivisions are included and are a great idea, but probably don't represent what Mr. Moyer has voiced in the past what the farmers are looking for.

A copy of Trout Unlimited's letter expressing concerns that riparian areas remain protected was given again to the Board.

Mrs. Schoch noted that more discussion can be held at the Supervisors/Planning Commission work session scheduled for April 7<sup>th</sup> at 7 p.m.

### **COMMITTEE REPORTS**

Mr. Wise reported that the MPO meeting was cancelled. He commented further that there is some discussion taking place about the possibility of bringing passenger train service to State College.

### **OLD BUSINESS**

Mammoth Construction Bond: Table.

<u>MOU with ClearWater Conservancy – Phase I Archaeological Investigation:</u> Mr. Franson and Mr. Abbey noted that ClearWater Conservancy has agreed to fund the Phase 1 study in coordination with the Spring Creek Canyon trail grant. Mr. Franson noted that with the possible ADA requirements in slopes on the proposed trail that by going ahead and doing the study that it may prove to be a benefit. Three proposal were received. (Rue Environmental LLC, Herberling Associates, Inc., and Skelly and Loy) Mr. Franson noted that he, Mr. Abbey and Mrs. Schoch reviewed all the proposals and ranked them on several different categories. Upon comparing rankings all three agreed that Rue Environmental LLC was the best fit for the project. Rue has completed prior work in the area and is very familiar with the location.

Mr. Wise moved to approve the Memo Of Understanding with ClearWater Conservancy for the Phase Istudy dealing with the Spring Creek Canyon Trail grant.Mr. Moyer seconded the motion.Vote:Mr. Capriani – yesMr. Moyer – yesMr. Wise – yes

Mrs. Alters suggested that after the trail is installed that it may be a good idea to install signage to keep pedestrians off of the lower trail.

Mr. Wise moved to award the Phase I study proposal to Rue Environmental LLC at the cost of \$9,193.00. Mr. Moyer seconded the motion.

<u>Village of Nittany Glen Rezoning Request:</u> The Board is in receipt of a letter from Penn Terra Engineering dated March 24, 2015 stating that the Village of Nittany Glen, LP – (the McKee Group) is withdrawing the current request to rezone portions of their property back to the R-2 Zoning District. The Board acknowledged receipt of the request.

#### **NEW BUSINESS**

**Grove Park Phase II Surety:** A surety renewal for Phase II of Grove Park was presented to the Board for their review and approval. It was noted that the amount is remaining the same at \$49,973.00. Mr. Capriani moved to approve a one year extension of the surety which expires 4/7/2016. Mr. Moyer seconded the motion.

**Benner Pike Sewerline Extension:** Mrs. Royer noted that the Township has been contacted to see how the Board feels about extending sewer service to 5 properties along the Benner Pike. These properties start after the Sunrise Mobile Home Park and go towards State College. Two of the properties are commercial, the one residential property owned by Hartle is malfunctioning. The Board noted that they support this extension project and were surprised that these properties weren't already connected.

**Officer Phil Program:** The Board is in receipt of a request, once again, from the Officer Phil Program. The Township normally pays for an ad in the booklets that are passed out as part of the local police programs in the elementary schools. It was noted that this year the booklets are focusing on safety from abductions. Mr. Wise moved to approve an ad in this publication once again. Mr. Moyer seconded the motion.
